The Tranche 1 Notes shall accrue no interest. The Tranche 2 Notes shall bear interest at a rate of 5% per annum from the date of issue payable semi-annually in arrears.

** The principal amount of HK\$608,000,000 Convertible Notes have comprised Tranche 1 Notes with the principal amount of HK\$190,000,000, Tranche 2 Notes with the principal amount of HK\$190,000,000 and Tranche 3 Notes with the principal amount of HK\$228,000,000. Each of the Tranche 1 Notes, the Tranche 2 Notes and the Tranche 3 Notes shall bear interest at a rate of 12% per annum from the date of issue payable semi-annually in arrears. The completion of the placing of Tranche 1 Notes took place on 15 October 2014. The completion of the placing of Tranche 2 Notes took place on 22 October 2014. The completion of the placing of Tranche 3 Notes took place on 29 October 2014. For details, please refer to the Company's circular dated 8 September 2014.
